## **Vaccinations Begin in Ohio**

On Monday, Ohio received its first batches of vaccinations at the Ohio State University Wexner Medical Center and the University of Cincinnati Medical Center, where the first vaccines were administered to healthcare workers. On December 18<sup>th</sup>, Ohio was among the first in the nation to administer the vaccine to those living and working in nursing homes as part of an early scaling up of the federal program through the CDC. ## Funding Amendments Added to Capital Bill

A number of amendments were added to SB 310, the bond-backed facility spending measure, late Thursday. The \$2.1 billion capital bill adopted a number of changes, including (but not limited to) a Medicaid fund shift, local matches for additional federal money for county developmental disability services, appropriating funds for school funding studies, creation and expansions of a number of programs, and ensuring that the emergency clause applies to the entire report. # House Advances Elimination of 'Duty to Retreat' Language

Late Thursday evening, the House voted 52-30 to eliminate the duty to retreat language through a contested floor amendment that was added into SB 175, which later passed 52-31 after debate was closed. This bill now heads to the Senate, who must concur with changes before the bill is sent to the Governor. Governor DeWine has said that this bill should be accompanied by his STRONG Ohio gun proposal, details of which can be found <a href="here">here</a>.

# **Introduced Bills**

<u>HB 804 – Constitutional Rights (Grendell):</u> To provide for a writ of mandamus or prohibition to enforce a person's constitutional right against a chief administrative officer or elected executive official whose duty is to uphold the Ohio and United States Constitutions.

<u>HB 805 – Liquor Permits (Miller, Carruthers):</u> To exempt specified liquor permit holders from the requirement to renew their permits in calendar year 2021 and to declare an emergency.
