DeWine Administration Releases Operating Budget

Following Governor DeWine's State of the State address, the Administration released its Executive Budget proposal, "Blue Book." The Executive Budget for FY 2024-2025 consists of three separate documents detailing spending and revenue, state tax expenditures, and budget highlights. Complete budget language is still being developed and should be released in the coming days.

DeWine Budget: New Agency Focused on Children

The Governor's Executive Budget proposal includes the creation of a new, cabinet-level agency focused on younger Ohioans. The Department of Children and Youth Services will combine issues identified within six existing agencies and focus on children's behavioral health, foster care access and reform, early childhood education, and physical health intervention for both mothers and children.

Speaker Stephens Revises House Schedule

House Speaker Jason Stephens has announced a revised legislative schedule for the chamber, including an additional session on April 20th, designating several session days as "If-Needed," and removing session dates in July.
